3. HAZARDS IDENTIFICATION

Main hazards: Flammable. Harmful by inhalation. Irritating to eyes and skin.Other hazards: May cause fire. May cause sensitisation by skin contact.

4. FIRST AID MEASURES (SYMPTOMS)

Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so.

5. FIRE-FIGHTING MEASURES
